CLASSES OF MEMBERSHIP

ACTIVE MEMBER: A full member, over 18 years of age, who may vote, hold office and use all the facilities of the Club. Dues are \$213.04/Qtr. Initiation Fee payable by either of 3 options. Option #1: Attach check for \$491.63. Option #2: Attach check for \$32.78 service charge, and then pay \$98.33/month for 5 months. Option #3: Attach check for \$65.55 service charge, and then pay \$49.16/month for 10 months. (All prices include sales tax.)

ASSOCIATE MEMBER: A non-voting, non-office-holding member over 18 years of age, who is a crew member or other person interested in sailing. An Associate Member cannot use any of the Club's facilities to park, launch or operate any boat he or she may own, rent or borrow from a non-member. He or she may use the Club's facilities in connection with a boat borrowed from an Active Member. Dues are \$106.52/Qtr. Attach check for \$54.63 Initiation Fee. (All prices include sales tax.)

ACTIVE JUNIOR MEMBER: A non-voting, non-office-holding member between the ages of 18 and 29, who may keep a sailboat at the Club. Membership terminates automatically on January 1st after the 28th birthday, unless converted to another class of membership. No private parties and no guests other than family and crew. Loss of Club use if dues 45 days past due, and automatic termination if dues 60 days past due. When Active Junior Members apply for Active or Associate Membership, they receive \$50 credit toward initiation fee for each full calendar year of service as an Active Junior. Dues are \$38.24/Qtr. Attach check for \$54.13 Initiation Fee. (All prices include sales tax.)

JUNIOR MEMBER: A non-voting, non-office holding member either under 18 years of age or a full-time undergraduate student. Dues are same as Active Member, if you keep a boat at the Club. Dues are same as Associate Member if you do not keep a boat at the Club. No Initiation Fee. Attach check for first quarter's dues to this Application. Membership terminates automatically on earlier of 19th birthday or end of undergraduate student status. May then apply for some other class of membership.

TEMPORARY MEMBER: A non-voting, non-office-holding nonresident or temporary resident of known duration. Dues are \$316.83 for six month term. No Initiation Fee. No refund in case of early withdrawal. May not renew Temporary Membership. At termination of six month term, may apply for another class of membership. (All prices include sales tax.)

RELEASE, HOLD HARMLESS AND INDEMNITY AGREEMENT

I hereby apply for membership in Harbor Island Yacht Club on the terms indicated on the reverse side of this Application. I agree that my family will abide by the Constitution, By-Laws, Dock Policy and other rules and regulations of HIYC. If accepted into membership in Harbor Island Yacht Club, I fully understand and agree that the Club assumes no liability whatever for accidental or other physical injury or loss to me, my family, my guests, my boat, my car or my other property. I understand and agree that, while the HIYC Board of Governors will make an honest, good faith effort to provide safe facilities, it does not guarantee or warrant the safety or serviceability of the moorings, docks, equipment, hoist, gang-planks, grounds or Clubhouse; and I and my family and my guests use these facilities at our own risk. In consideration for the benefits of membership, I hereby release all my own past and future claims against the Club and its personnel, and I agree to hold harmless and indemnify the Club from all liability for claims by my family and my guests for any loss or damage.
