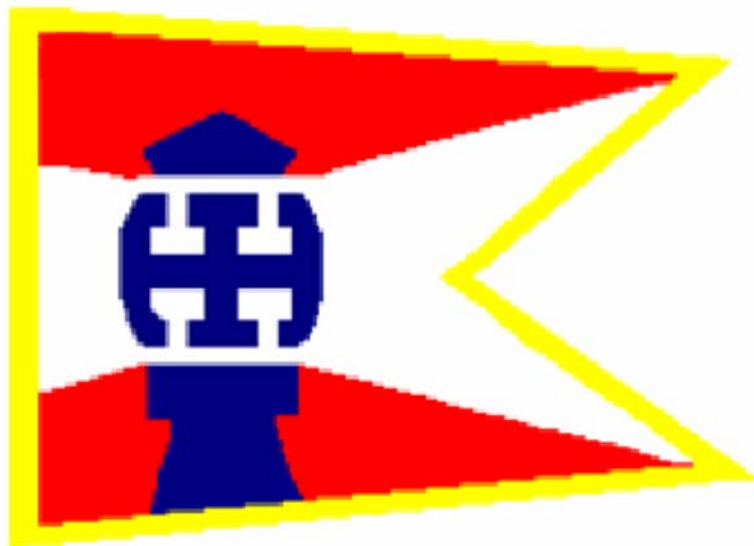
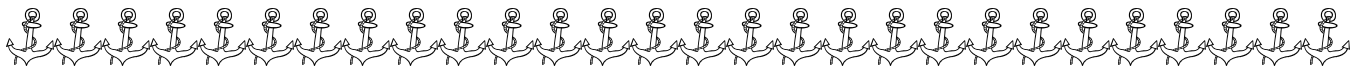

## **MEMBERSHIP APPLICATION**

## HARBOR ISLAND YACHT CLUB - MEMBERSHIP APPLICATION

**BOARD ACCEPTANCE:** Applicants will be invited to the next monthly Board Meeting for a brief interview. This is an opportunity to meet the applicant to put a face to a name, and find out a little more about an applicant and their interests in HIYC. Your Application will then be acted upon. As soon as you are notified of acceptance, you should immediately get the Harbormaster's phone number from your sponsor, and arrange a place for your boat on Club property or on the water. Also, ask your sponsor for a list of current activities so you may immediately begin full participation.

**BOAT REGISTRATION:** All boats on moorings or in the water at slips must be registered with the Tennessee Wildlife Resources Agency (TWRA), and display current boat registration in accordance with the law. Boat owners not in compliance are subject to fines by TWRA.

**SPACE AVAILABILITY:** In the event that an application for an Active Membership is received when there is no space at HIYC for the applicant's boat, the application will be treated as an application for an Associate Membership.

**Memberships are non-transferable.**

### CLASSES OF MEMBERSHIP

**ACTIVE MEMBER:** Individuals over 18 years of age (except those individuals duly elected to Junior Membership) duly elected to membership who have paid an initiation fee as provided in the by-laws. They shall have full voting privileges and the right to hold office. A member's spouse and unmarried dependents under age 25 shall be entitled to the privileges of the Club. A member's spouse and unmarried dependents under age 25 shall be entitled to the privileges of the Club. Dues are \$213.04/quarter. Initiation Fee payable by either of 3 options: Option 1: Attach check for \$491.63. Option 2: Attached check for \$32.78 service charge, charge, and then pay \$98.33/month for 5 months. Option 3: Attach check for \$65.55 service charge, and then pay \$49.16/month for 10 months. (Initiation Fee and Dues include required sales tax.)

**ASSOCIATE MEMBER:** Individuals over eighteen years of age (except those individuals duly elected to Junior Membership), not maintaining a boat at the Club, duly elected to membership, who have paid an initiation fee as set forth in the by-laws. Such members do not have the right to vote or to hold office. Dues are \$106.52/quarter. Attach check for \$54.63 Initiation Fee, payable in full with application. (Initiation Fee and Dues include required sales tax).

**JUNIOR MEMBER:** Individuals between the ages of 18 and 29 years, duly elected to membership who have paid an initiation fee as provided in the by-laws. Such members shall not have the right to vote, hold office or have private parties, but may maintain a boat at the Club. Guests of such members at the Club shall be limited to crew and family. Junior Membership shall terminate on January 1 following such member's 28th birthday. When Junior Members apply for Active or Associate Membership, they receive \$50 credit toward initiation fee for each full calendar year of service as a Junior Member. Dues are \$38.24/quarter. Attach check for \$54.13, Initiation Fee, payable in full with application. (Initiation Fee and Dues include required sales tax).
